- For possible action: Discussion and adoption of changes to MSM Chapter 2100 Home and Community Based Services (HCBS) Waiver for Individuals with Intellectual and Developmental Disabilities, MSM Chapter 2200 – HCBS Waiver for Frail Elderly, and MSM Chapter 3900 – HCBS Waiver for Assisted Living.

Revisions to MSM Chapter 2100 are being proposed to align with the current Waiver for Individuals with Intellectual and Developmental Disabilities (ID Waiver) renewal which was approved on October 1, 2018, to include language from the CARES Act where HCBS can be provided in an acute care setting, changes to the intake process, and updates to the language for consistency and clarity throughout the chapter.

Revisions to MSM Chapter 2200 are being proposed to align with the recent approved Frail Elderly (FE) Waiver renewal, to include language from the CARES Act where HCBS can be provided in an acute care setting, changes to the intake process, and updates to the language for consistency and clarity throughout the chapter.

Revision to remove MSM Chapter 3900 is being proposed as the Assisted Living (AL) Waiver expired June 30, 2014 and was combined with the FE Waiver effective July 1, 2014. Services provided under AL will be moved to MSM Chapter 2200 HCBS Waiver for FE.

Entities financially affected: This proposed change affects all Medicaid-enrolled waiver providers delivering waiver services. Those provider types (PT) include but are not limited to: Waiver for Intellectual and Developmental Disabilities (PT 38), Frail Elderly Waiver (PT 48), Adult Residential Care (PT 57), Assisted Living (PT 59).

Anticipated financial impact on local government: Unknown at this time.

Revisions to MSM Chapter 1900 – Transportation Services are being proposed to define the policy and coverage of Non-Emergency Secure Behavioral Health Transports, based on regulations passed due to Assembly Bill 66 from the 2019 Legislative Session. Minor formatting revisions are also being proposed to the Non-Emergency Transportation (NET) policy section within MSM Chapter 1900.

Entities financially affected: This proposed change affects all Medicaid-enrolled providers delivering non-emergency secure behavioral health transport services. Those provider types (PT) include but are not limited to: Specialty 987 (PT 35); Non-Emergency Secure Behavioral Health Transports; (PT 32), Ambulance, Air, or Ground.

Anticipated financial impact on local government:

Revisions to MSM Chapter 4000 are being proposed to include an additional care coordination model, Safety Assessment Family Evaluation (SAFE), to be utilized by the local county agencies when evaluating individuals to be eligible for these services.

Entities financially affected: This proposed change affects all Medicaid-enrolled providers delivering Intensive In-Home Supports and Services and Crisis Stabilization Services. Those PTs include, but are not limited to Specialized Foster Care Services (PY 86).

Anticipated financial impact on local government: The financial impact on local government is unknown at this time
