- 2. **For possible action:** Discussion and adoption of changes to MSM Chapter 3800 Medication-Assisted Treatment

Revisions to MSM Chapter 3800 are being proposed to align with new buprenorphine practice guidelines published by the Department of Health and Human Services that among other things, remove a long time requirement tied to training, which some practitioners have cited as a barrier to treating more people. These revisions include updating exemption language related to training, counseling and other ancillary services for providers prescribing to 30 or fewer patients, and added annual reporting requirements for qualified providers approved to treat up to 275 patients.

Entities Financially Affected: This proposed change affects all Medicaid-enrolled providers delivering MAT services for OUD. Those provider types (PT) include, but are not limited to: Physician, M.D., Osteopath, D.O. (PT 20), Advance Practice Registered Nurse (PT 24), Nurse Midwife (PT 74), Physician's Assistant (PT 77), and Substance Abuse Agency Model (SAAM) (PT 17 Specialty 215).

**Financial impact on local government:** Unknown at this time.
