Revisions to MSM Chapter 200 are being proposed to update the Authority page to reflect accurate titles and descriptions, a revised table to replace the Newborns and Neonatal Intensive Care Unit (NICU) level of care crosswalk table, along with the removal of the utilization of InterQual and MCG medical care guidelines.
  - b. In addition, as a result of the passing of Assembly Bill 287 from the 81<sup>st</sup> Legislative Session, language updates throughout MSM Chapter 200 and MSM Chapter 600 renaming birth centers and obstetric centers to freestanding birthing centers. Lastly, the removal in MSM Chapter 200 of two accreditation organizations and Memorandum of Understanding requirements for freestanding birthing centers.

Entities Financially Affected: Provider Type (PT) 11 — Inpatient Hospital, PT 17-169 — Birth Centers, and PT 75 — Critical Access Hospital (CAH).

Financial impact on local government: No financial impact Unknown at this time.

Revisions to MSM Chapter 400 (Attach C) are being proposed to remove the language "for pregnant women only" from any association with Tobacco Cessation.

**Entities Financially Affected** This proposed change affects all Medicaid-enrolled providers delivering Tobacco Cessation Counseling type of services. Those PTs include but are not limited to: Special Clinics (PT 17), Behavioral Health Outpatient Treatment (PT 14), Physician M.D. Osteopath D.O. (PT 20), Physician Assistant (PT 77), and Advanced Practice Registered Nurses (PT 24).

Financial impact on local government: Unknown at this time
