Revisions to MSM Chapter 3600 are being proposed to align with the new contract held with the contracted Managed Care Organizations (MCOs). The proposed changes include revisions and clarification to existing policy related to MCO responsibility and coverage of Certified Community Behavioral Health Centers (CCBHCs); Residential Treatment Centers (RTC); and Population Health program.

**Entities Financially Affected:** This proposed change affects all Nevada Medicaid MCOs.

Financial impact on local government: No expected fiscal impact.

Effective date: January 1, 2022.

- 3. For possible action: Discussion and adoption of changes to MSM Chapter 600 Physician Services

Revisions to MSM Chapter 600 are being proposed to add a new provider, Doulas, a result of the passage of Assembly Bill (AB) 256 and Senate Bill (SB) 420 during the 81<sup>st</sup> Legislative Session. Doula services include education, emotional and physical support during pregnancy, labor, delivery, and postpartum period.

Entities Financially Affected: Doula (PT 90); Special Clinics (PT 17 including specialties Rural Health Clinics (180), Federally Qualified Health Centers (181) and Licensed Birth Centers (169)); Physician, M.D., Osteopath, D.O. (PT 20); Advanced Practice Registered Nurses (PT 24); Indian Health Programs (PT 47); Nurse Midwives (PT 74); and Physician Assistants (PT 77).

Financial impact on local government: An estimated decrease in annual aggregate expenditures for doula services:

SFY 2022: (\$420,772) SFY 2023: (\$848,600)

**Effective date:** The changes for doulas are effective January 1, 2022 pending CMS approval but also are contingent upon Nevada Certification Board doula certification implementation.

4.3. For possible action: Discussion and adoption of changes to MSM Chapter 600 – Physician Services

Revisions to MSM Chapter 600 are being proposed to add a new provider, Community Health Workers (CHWs), a result of the passage of Assembly Bill (AB) 191 and Senate Bill (SB) 420 during the 81<sup>st</sup> Legislative Session. CHWs provide recipients culturally and linguistically appropriate health education for the prevention and management of chronic disease under the supervision of a Nevada Medicaid enrolled Physician, Advanced Practice Registered Nurse (APRN) or Physician Assistant (PA).

Entities Financially Affected: Community Health Worker (PT 89); Special Clinics (PT 17 including specialties Rural Health Clinics (180), Federally Qualified Health Centers (181) and Licensed Birth Centers (169)); Physician, M.D., Osteopath, D.O. (PT 20); Advanced Practice Registered Nurses (PT 24); Indian Health Programs (PT 47); Nurse Midwives (PT 74); and Physician Assistants (PT 77).

**Financial impact on local government:** An estimated decrease in annual aggregate expenditures for CHW services:

SFY 2022: (\$199,486) SFY 2023: (\$839,241)

Effective date: The changes for CHWs are effective January 1, 2022 pending CMS approval.
