Subject: Fee-for-Service (FFS) Rate Reductions affecting all Medicaid-enrolled providers delivering services under Provider Type (PT) 86 (Specialized Foster Care)

The DHCFP is proposing an amendment to the Nevada State Plan, Attachment 4.19-B, page 18f to amend the reimbursement methodology for Specialized Foster Care (SFC). The proposed changes will apply to services performed by non-governmental entities or governmental entities that do not undergo Medicaid cost identification and reporting procedures.

Methodology: Rates for this provider type are market based, using a model to reflect service definitions, provider requirements, operational service delivery and administrative considerations. In order to achieve the 6% rate reductions, a factor of 0.94 was multiplied by the rates in effect upon publication of this agenda.

Estimated change in annual aggregate expenditures: An estimated decrease in annual aggregate expenditures for PT 86:

SFY 2021: (\$23,136) SFY 2022: (\$569,995)

The effective date of change is June 1, 2021.

3. Discussion of proposed Amendments to the State Plan for Medicaid Services and solicitation of public comments

Subject: Specialty Pharmacy Drug Program

In accordance with Nevada Special Legislative Session, Assembly Bill 3, the DHCFP is proposing revisions to the State Plan, Attachment 4.19-B, Page 3 and Page 3 (Continued) for Prescribed Drugs. The State has elected to utilize selective contracting in order to deliver optimal therapy management with sufficient utilization controls for specialty pharmacy drugs used in the treatment of Hemophilia, Hepatitis C and Intravenous Immunoglobulin within the FFS program. The DHCFP has established a new payment algorithm for these specific drugs. Further, the DHCFP has created a professional service contract in which the vendor provides clinical and customer service support to recipients and ordering providers.

Entities Financially Affected: Providers who prescribe, dispense or administer this drug may be affected by this change, including but not limited to the following PTs: Outpatient Surgery (PT 10); Hospital, Inpatient (PT 11); Hospital, Outpatient (PT 12); Intermediate Care Facilities for Individuals with Intellectual Disabilities, Public (PT 16); Special Clinics (PT 17); Nursing Facility (PT 19); Physician/Osteopath (PT 20); Podiatrist (PT 21); Advanced Practice Registered Nurse (PT 24); Pharmacy (PT 28); Home Health Agency (PT 29); Ambulatory Surgical Centers, Freestanding (PT 46); Indian Health Programs and Tribal Clinics (PT 47); Indian Health Service Hospital, Inpatient (Tribal) (PT 51), Indian Health Service Hospital, Outpatient (Tribal) (PT 52); Transitional Rehabilitative Center, Outpatient (PT 55); Inpatient Rehabilitation and Long Term Acute Care (LTAC) Specialty Hospitals (PT 56); Hospice (PT 64); Hospice, Long Term Care (PT 65); Intermediate Care Facilities for Individuals with Intellectual Disabilities, Private (PT 68); Nurse Anesthetist (PT 72); Critical Access Hospital (CAH), Inpatient (PT 75); Audiologist (PT 76); Physician's Assistant (PT 77); Indian Health Service Hospital, Inpatient (Non-Tribal) (PT 78); Indian Health Service Hospital, Outpatient (Non-Tribal) (PT 79).

Estimated change in annual aggregate expenditures: None known at this time.

The effective date of change is July 1, 2021.

State Plan Amendments can be back dated to the first of the quarter in which they are heard. If none is given, the default is the day after the public hearing.

Per Nevada Governor Sisolak's Declaration of Emergency Directive 006; Subsection 3: The requirements contained in NRS 241.020 (4)(a) that public notice agendas be posted at physical locations within the State of Nevada are suspended.

Per Nevada Governor Sisolak's Declaration of Emergency Directive 006; Subsection 4: Public bodies must still comply with requirements in NRS 241.020 (4)(b) and NRS 241.020 (4)(c) that public notice agendas be posted to Nevada's notice website and the public body's website, if it maintains one along with providing a copy to any person who has requested one via U.S. mail or electronic mail.
