Revisions to MSM Chapter 600 are being proposed to add a new provider, Doulas, a result of the passage of Assembly Bill (AB) 256 and Senate Bill (SB) 420 during the 81st Legislative Session. Doula services include education, emotional and physical support during pregnancy, labor, delivery, and postpartum period.

Entities Financially Affected: Doula Provider Type (PT 90), Outpatient hospitals (PT 12), Special Clinics (PT 17) and Specialty 180 Rural Health Clinics, Specialty 181 Federally Qualified Health Centers, Specialty 169 Licensed Birth Centers; Physician, M.D., Osteopath, D.O. (PT 20); Advanced Practice Registered Nurses (PT 24); Indian Health Programs (PT 47); Nurse Midwives (PT 74); and Physician Assistants (PT 77).

Financial impact on local government: An estimated decrease in annual aggregate expenditures for Doula Services:

SFY 2022: (\$420,772) SFY 2023: (\$848,600)

Effective date: The changes for Doulas are effective April 1, 2022, pending Centers for Medicare and Medicaid Services (CMS) approval and Nevada Certification Board Doula certification implementation.

Revisions to MSM Chapter 2900 are being proposed to add a new provider, Doulas, a result of the passage of Assembly Bill (AB) 256 and Senate Bill (SB) 420 during the 81st Legislative Session. Doula services include education, emotional and physical support during pregnancy, labor, delivery, and postpartum period.

Entities Financially Affected: Doula (PT 90), Special Clinics (PT 17) and Specialty 181-Federally Qualified Health Centers.

Financial impact on local government: An estimated decrease in annual aggregate expenditures for Doula services:

SFY 2022: (\$420,772) SFY 2023: (\$848,600)

Effective date: April 1, 2022, pending CMS approval.

- 4. **For possible action:** Discussion and adoption of changes to MSM Chapter 400 Mental Health and Alcohol and Substance Abuse Services

Revisions to MSM Chapter 400 - Mental Health and Alcohol and Substance Abuse Services are being proposed to ensure that crisis stabilization services provided at hospitals with a crisis stabilization center endorsement are covered and reimbursable services under Nevada Medicaid pursuant to Senate Bill 156 proposed during the 2021 legislative session. The goal of this legislation is to add a place to go as a critical element of the crisis continuum of care to support an array of crisis services critical in caring for individuals experiencing a behavioral health crisis. New proposed policy documentation includes scope of services for crisis stabilization centers, their primary objective, requirements, best practices, provider responsibilities, admission criteria and authorization process. Crisis stabilization centers best patient outcomes may include immediate care and a more positive behavioral health crisis response. Providers will be reimbursed a daily default rate and after an individual and complete fiscal year of providing services, will be allowed to complete a cost report, of which an individual rate will be calculated.

Entities Financially Affected: This proposed change affects all Medicaid-enrolled providers delivering crisis stabilization services. Those PTs include but are not limited to: Hospital, Inpatient (PT 11), Hospital, Outpatient (PT 12) and Psychiatric Hospital, Inpatient (PT 13).

Financial impact on government: The estimated financial impact is anticipated to result in a savings of:

SFY 2022: (816,333) SFY 2023: (\$12,122, 807)

- 5. For possible action: Discussion and adoption of changes to MSM Chapter 400 Mental Health and Substance Abuse Services. (Note: this change reverts policy in light of a withdrawn SPA related to previous changes dated July 2021).

Revisions are being made to MSM Chapter 400 — Mental Health and Alcohol and Substance Abuse Services to revert policy for Biofeedback and Neurotherapy services for the treatment of a mental health diagnosis. Neurotherapy is individual psychological therapy incorporating biofeedback training combined with psychotherapy as a treatment for mental health disorders. After several months of discussion with CMS regarding the elimination of these services as a result of the approved DHCFP budget during the 2021 Legislative session, CMS determined that this elimination violated the maintenance of effort (MOE) requirements of Section 9817 of American Rescue Plan Act (ARPA) of 2021 and pursuing these eliminations now would jeopardize the state's ability to receive enhanced funding for Home and Community Based Services (HCBS) available under ARPA. Nevada will withdraw NV SPA 21-0009 and re-evaluate consideration of these services when the MOE requirements expire on March 4, 2024.

Entities Financially Affected: Including PTs, but not limited to, Hospital, Outpatient (PT 12); Behavioral Health Outpatient Treatment (PT 14); Physician, M.D., Osteopath D.O. (PT 20); Advanced Practice Registered Nurse (PT 24); Psychologist (PT 26); Physician's Assistant (PT 77); and Behavioral Health Rehabilitative Treatment (PT 82), and Certified Community Behavioral Health Center (PT 17 Specialty 188).

Financial impact on local government: At this time, the fiscal impact is estimated to result in an approximate SFY cost of:

SFY 2022: \$28,024,136 SFY 2023: \$28,299,314
