Medicaid State Plan Section 3 – Attachment 3.1-I-1: Updates to SPA regarding provider qualifications, pages 14, 15 and 16.

The Division of Health Care Financing and Policy (DHCFP) is proposing changes to the Nevada State Plan provider qualifications for Day Habilitation and Residential Habilitation service. The requirement for Comprehensive Accreditation for Rehabilitation Facilities (CARF) certification will be replaced by the Brain Injury Fundamentals Certification through the Brain Injury Association of America. Day Habilitation facilities will be licensed as Facility for Care of Adults During the Day under the Division of Public and Behavioral Health (DPBH), Bureau of Health Care Quality and Compliance (BHCQC). Residential Habilitation facilities will be licensed as Residential Facilities for Groups under DPBH, BHCQC.

- a. Medicaid State Plan Section 3 – Attachment 3.1-I-1: Quality Improvement Strategies, pages 20 – 36.

The DHCFP is proposing updates to the quality measures of the Quality Improvement Strategies to improve the state's discovery, monitoring and remediation strategies.

- b. Alternative Benefit Plan – Section 7. Essential Health Benefit: Rehabilitative and habilitative services and devices, pages 8 and 9.

The DHCFP is proposing updates to Alternative Benefits Plans Section 7 for Adult Day Health Care authority and separation of Home Based Habilitation into two different services of Day Habilitation and Residential Habilitation services.

The following Provider Type (PT) affected by this change include Adult Day Health Care (PT 39) and Day and Residential Habilitation Services (PT 55).
