#### Introduction:

Casey Angres, Chief of Division Compliance, DHCFP, opened the Public Hearing introducing herself, Malinda Southard, Deputy Administrator, DHCFP, and Karen Griffin, Senior Deputy Attorney General.

Casey Angres – The notice for this public hearing was published on January 25, 2024, in accordance with Nevada Statute 422.2369.

1. Public Comments: Jay Kolbet-Clausell, Program Manager, NVCHWA, asked for clarity on the billable services for Community Health Workers (CHW) who are working in behavioral health settings. Jay Kolbet-Clausell advised he noticed this was an excluded activity on the draft list that was released. The CHW could be working under social workers or licensed professionals who might be doing those tasks. He asked how those supports are defined in those more behavioral health focused settings.

# 2. Discussion and Proposed Adoption and Changes to MSM 600

# Subject: MSM Chapter 600 – Physician Services

Carin Fox Hennessey, Program Specialist, Medical Benefits Coverage, DHCFP, advised pursuant to the passing of Senate Bill (SB) 117 during the 82nd Legislative Session in 2023, the Nevada MSM Chapter 600 – Physician Services, Section 605.2(C) is being revised. This update will add prior authorizations for medically necessary services after the initial service limitations of four units (30 minutes per unit) in a 24-hour period, not to exceed 24 units per calendar month per recipient.

This proposed policy update may affect the following Provider Types (PT) including but not limited to: Community Health Workers (PT 89).

The effective date of this new policy is March 1, 2024.

# 3. Discussion and Proposed Adoption and Changes to MSM 800

# Subject: MSM Chapter 800 – Laboratory Services

Carin Fox Hennessey, Program Specialist, Medical Benefits Coverage, DHCFP, advised pursuant to the passing of Assembly Bill (AB) 155 during the 82nd Legislative Session in 2023, the Nevada MSM Chapter 800–Laboratory Services, Section 803.1C is being revised. This update will add prior authorizations for cancer biomarker testing. There is also the addition of language referring to MSM Chapter 3100 for appeals or denials of biomarker testing.

This proposed policy update may affect the following PTs including but not limited to: Inpatient Hospital (PT 11), Outpatient Hospital (PT 12), and Laboratory (PT 43).

The effective date of these changes is March 1, 2024.
