2. **For possible action:** Discussion and adoption of changes to MSM Chapter 1200 – Prescribed Drugs

Revisions to MSM Chapter 1200 are being proposed to update the links within to prior authorization forms and preferred drug list and add coverage for Continuous Glucose Monitors (CGM) for recipients with Diabetes Mellitus II (Type II) to align with standards of care.

Entities Financially Affected: This proposed change affects all Medicaid-enrolled providers delivering Diabetic Supply type of services. Those provider types (PT) include but are not limited to: Pharmacy (PT 28), Inpatient Hospitals (PT 11), Outpatient Hospitals (PT 12), Nursing Facilities (PT 19), DMEPOS (PT 33), and Indian Health Services and Tribal Clinics (PT 47).

Financial impact on local government: Fiscal savings to DHCFFP.

3. **For possible action:** Discussion and adoption of changes to MSM Chapter MSM 1200 – Prescribed Drugs

Revisions to MSM Chapter 1200 are being proposed to <Include a statement of the need for and purpose of the proposed regulation, and either the terms or substance of the proposed regulation or a description of the subjects and issues involved. to reflect recommendations approved on October 19, 2023, by the Drug Utilization Review (DUR) Board meeting. The addition of Spevigo® (spesolimab-sbzo) under Immunomodulator Drugs, including updated PA guidelines. Under Section MMM – Duchenne Muscular dystrophy (DMD) Agents, Elevidys™ (Delandistrogene Moxeparvovec-Rokl) was added and under Section GGGG – Relyvrio® (sodium phenylbutyrate/taurursodiol) Qalsody™ (Tofersen) was added. Vyjuvek™ (beremagene geperpavec-svdt) has been added to new Section KKKK. Section LLLL to Section SSSS have been added for the following new drugs:

Hemgenix® (etranacogene dezaparvovec-drlb), Roctavian™ (valoctocogene roxaparvovec-rvox), Evkeeza™ (evinacumab-dgnb), Joenja® (leniolisib), Daybue™ (trofinetide), Elfabrio® (pegunigalsidase alfa-iwxj), Xiaflex® (collagenase clostridium histolyticum) and Skyclarys® (omaveloxolone).

Entities Financially Affected: No entities are financially affected.

Financial impact on local government: No impact on local government known.

4. **For possible action:** Discussion and adoption of changes to MSM Chapter 400 – Mental Health and Alcohol/Substance Use Services.

Revisions to MSM Chapter 400 are being proposed to update the time and distance standards for Mobile Crisis Response Delivered by A Designated Mobile Crisis Team (DMCT). Clarification is provided for team members who are certified peer and recovery support services providers.

Entities Financially Affected: This proposed change affects all Medicaid-enrolled providers delivering DMCT services. Those PTs include but are not limited to Behavioral Health Outpatient (PT 14), Certified Community Behavioral Health Center (PT 17) and Crisis Services (PT 87).

Financial impact on local government: No financial impact is expected.

5. **For possible action:** Discussion and adoption of changes to MSM Chapter 2900 Federal Qualified Health Centers.

Revisions to MSM Chapter 2900 are being proposed to clarify language around Mental/Behavioral Health encounters. The updated language identifies qualified providers of Mental/Behavioral Health encounter services; providers shall deliver services under the scope & practice of their licensure using appropriate diagnostic tools for behavioral health treatment. Language around mental health and substance use treatment including co-occurring treatment has been updated, in alignment with MSM Chapter 400.

Entities Financially Affected: The proposed updates affect all Medicaid-enrolled providers delivering mental health and substance use treatment including co-occurring treatment services in a Federally Qualified Health Center setting. Those PTs include but are not limited to: Behavioral Health, Outpatient Treatment (PT 14), Psychologist (PT 26), Special Clinics (PT 17, Specialty 181).

Financial impact on local government: Unknown at this time.
