- 2. Discussion of Amendments to the State Plan for Medicaid Services and Solicitation of Public Comments

Subject: Rate Update for Provider Type 91 Pharmacists

Sean Linehan, Management Analyst, Rates Analysis and Development Unit, DHCFP, presented the Division is proposing an amendment to the Nevada Medicaid State Plan Attachment 4.19-B, Pages 1e (continued). During the 2023 Nevada Legislative Session, Senate Bill (SB) 439 was passed and signed into law. Per the

terms of this bill, the Nevada Medicaid State Plan must be updated to allow advance practice registered nurses (APRNs) and physician assistants (PAs) to be paid in parity with physicians when providing services to test for, treat, or prevent human immunodeficiency virus (HIV) or hepatitis C. Please note that although APRNs are included in SB 439 under specific circumstances, full parity for APRNs was included in SB 504 of the 2023 Nevada Legislative Session. This agenda item only addresses parity for PAs under the conditions described in the bill. Additionally, under NRS 422.27235 Provider Type (PT) Pharmacists (PT 91), will be in parity with Physician Assistants (PT 77).

This State Plan Amendment (SPA) is anticipated to impact providers of Pharmacists Services. This PT includes Pharmacists (PT 91).

There is an estimated change in annual aggregate expenditures for SFY 2024 and 2025 to include an increase of:

The effective date of these changes is April 1, 2024.

3. Discussion of Amendments to the State Plan for Medicaid Services and Solicitation of Public Comments

Subject: SPA Attachment 4.19-A, Indigent Accident Fund

Melissa Madera, Management Analyst, Supplemental Reimbursement Unit located in the Fiscal Services Unit, DHCFP, advised DHCFP is proposing an amendment to the Nevada Medicaid State Plan that would allow the continuation of the Hospital Indigent Fund (HIF), also known as the Indigent Accident Fund (IAF), supplemental payment program based on inpatient hospital utilization to preserve access to inpatient acute services through SFY 2025. This amendment will decrease the supplemental payments from \$70,196,969.02 in SFY 2024 to \$65,363,566.87 which results in a decrease in annual aggregate expenditures of (\$4,833,402). These changes are reflected in Nevada Medicaid's State Plan Attachment 4.19-A, Page 32b.

The following PT that will potentially be affected by this change includes Hospital, Inpatient (PT 11).

The effective date is July 1, 2024.

4. Discussion of Amendments to the State Plan for Medicaid Services and Solicitation of Public Comments

Subject: SPA Attachment 4.19-A, Disproportionate Share Hospitals (DSH)

Melissa Madera, Management Analyst, Supplemental Reimbursement Unit located in the Fiscal Services Unit, DHCFP, presented DHCFP intends to submit a Medicaid SPA to allow the continuation of the DSH distribution in SFY 2025. This amendment will also increase the allotment amount from \$22,432,159.05 in SFY 2024 to \$25,158,225.17 in SFY 2025 which results in an annual aggregate increase of \$2,726,066.12. These changes are reflected in Nevada Medicaid's State Plan Attachment 4.19-A, Page 23 and 24.

The Division also intends to submit an update to the payment frequency on Page 24. This update will change the DSH payment frequency from monthly to quarterly.

The PTs that will potentially be affected by this change include but are not limited to: Hospital Outpatient Surgery (PT 10), Hospital, Inpatient (PT 11), Hospital Outpatient (PT 12), Critical Access Hospital) Hospital Inpatient (PT 75).

The effective date is July 1, 2024.

Public Comments: There were none.
