Introduction:

Casey Angres, Chief of Division Compliance, DHCFP, opened the Public Hearing introducing herself, Theresa Carsten, Deputy Administrator, DHCFP, and Lauren M. Driscoll, DAG.

Casey Angres – The notice for this public hearing was published on January 23, 2025, in accordance with Nevada Statute 422.2369.

1. Public Comments: There were none.

2. Discussion of Amendments to the State Plan for Medicaid Services and Solicitation of Public Comments

Subject: Increase in Federal Poverty Level for Pregnant Women to 200%

Heather Koehler Social Services Program Specialist III, DWSS presented that Assembly Bill (AB) 432/Senate Bill (SB) 420 in the 2021 Legislative Session mandated Medicaid eligibility for pregnant women increase the allowable income limit from the current 165% of the federal poverty level (FPL) to a maximum income of 200% FPL. This increase will expand the number of women who could qualify for Medicaid during their pregnancy.

The following Provider Types (PT) will potentially be affected by this change. Those PTs include, but are not limited to, the PTs listed on the agenda.

There is an estimated increase in annual aggregate expenditures for State Fiscal Years (SFY) 2026 and 2027:

SFY 2026:	\$2,078,342
SFY 2027:	\$2,193,493

The effective date of change is July 1, 2025.

Public Comments:

JC Flowers advised when looking at the PTs, he did not see Federally Qualified Health Care (FQHC) centers and inquired if that is intentional or is that something that is missing.

Heather Koehler answered she will follow up offline with an answer.

JC Flowers replied that he did see Indian Health Services (IHS) but not FQHCs.

3. Discussion of Amendments to the State Plan for Medicaid Services and Solicitation of Public Comments

Subject: Psychiatric Hospital Rate Parity

Patricia Schille, Management Analyst, Rates Analysis and Development Unit, DHCFP, presented the State Plan for Medicaid Services Rate Change for Freestanding Psychiatric Hospitals (PT 13) to a flat statewide per diem rate to be in parity with the Nevada General Acute Hospitals providing psychiatric services. DHCFP intends to submit a Medicaid State Plan Amendment (SPA) in order to provide a rate change to Freestanding Psychiatric Hospitals to a flat statewide per diem rate to be in parity with the Nevada General Acute Hospitals providing psychiatric services. The flat statewide per diem rate will be \$944.00.

There is an estimated increase in annual aggregate expenditures for SFYs 2026 and 2027:

SFY 2026: \$5,651,252

SFY 2027: \$5,687,684

The effective date is April 1, 2025.

The change is a result of the commitment to enhance access to high-quality psychiatric care and support the sustainability of our healthcare providers. The change to the fee schedule will be the change to the per diem of \$944

Public Comments:

Vincenzo Variale, CEO of North Vista Hospital, mentioned that freestanding does provide a vital concern; however, he raised a concern that there used to be four general hospitals in Las Vegas to provide psychiatric care but there are only three now and general hospitals have not had a rate increase in 11 years. General hospitals provide a higher level of care (LOC). When there is a medical problem with a psychiatric patient, the freestanding refers the psychiatric patients to the general hospitals where they provide 24-hour medical attention. Variale stated that he meant no disrespect to freestanding but he used to manage freestanding; he said it was four walls and a bed with a nurse walking up with pills in a cup. He raised the concern that freestanding would be getting paid the same rate he gets and mentioned that his costs in 11 years have gone up immensely. During COVID, his hospital was the only one that took care of psychiatric patients who had COVID. Due to the medical complexity of the patients' needs, freestanding would not provide that care. Variale asked if Medicaid was going to raise the general hospital rates to the \$944 because he provides full medical attention as well as psychiatric needs. He emphasized the fact that general hospitals need a rate increase because in 11 years, their costs have gone up exponentially.

Casey Angres thanked Vincenco Variale for his comments and advised him to send his contact information to the document control email inbox for someone to reach out to further discuss this with him.
