Specialty Pharmacy Drug Program (SPDP) - Overview

The SPDP is intended to serve Nevada Medicaid recipients by delivering selected specialty drugs for treatment through various contracted specialty pharmacies.

What are specialty drugs?

- Specialty drugs are prescription medications that require special handling, administration or monitoring. These drugs treat complex and chronic conditions such as cancer, hemophilia and chronic kidney failure.





Specialty Pharmacy Drug Program (SPDP) - Overview

Who is impacted by the SPDP?

- The program applies to Nevada Medicaid recipients whose pharmacy services are covered under the Fee-For-Service (FFS) delivery system.



Which specialty drugs are impacted by the SPDP?

- The program will apply to the Hemophilia, Hepatitis C and Intravenous Immunoglobulin (IVIG) drugs only.
- There is an estimate 377 recipients that will be impacted by the SPDP.



Specialty Pharmacy Drug Program (SPDP) - Overview

Optum® Specialty Pharmacy will be managing the SPDP for Nevada Medicaid recipients.

What services does the specialty pharmacy provide?

- Holistic patient management
 - Therapy Solutions, sites of care, hospital discharge programs
- Expert clinicians
 - Patient counseling, education and monitoring
- Innovative engagement technologies
 - Virtual visits, video series, patient portal, mobile app
- State-of-the-art infrastructure
 - Regional and central fill pharmacies serving patients nationwide as well as 24/7 access to pharmacist to answer recipient's questions.





Program Objectives




The SPDP will be implemented with the following set objectives:


