- 1. Presentation and public comment
 - a. The purpose of this workshop is to discuss the three new provider types to offer added services for Nevada Medicaid. The discussion will be related to rates and the proposed changes to the state plan.

As a result of the 81st session of the Nevada Legislature (2021), three new services will be added to Nevada Medicaid:

- 1. Doulas Senate Bill (SB) 420: A doula is a non-medical trained professional who provides education, emotional and physical support during pregnancy, labor, birth, and post-partum period. Doulas may provide services during the pregnancy, labor, birth, and post-partum period within the home, office, hospital, or obstetrics center setting.
- 2. Community Health Workers (CHW) SB 420: CHWs are certified health educators working to educate recipients and help them navigate often complex medical, social, and behavioral health services. Services often involve teaching the patient how to self-manage his or her health effectively in conjunction with the health care team.
- 3. Pharmacists SB 325: Pharmacists will have the capability to bill for prescribing and dispensing of self-administered hormonal contraceptives and HIV prevention medications and Clinical Laboratory Improvement Amendments (CLIA) waived tests.
