MSM 1300 Proposed Updates

- 1303.1.A 4 and 5 – Medical necessity, duplicate services, and direction for deluxe definition.
- 1303.1.B.9 and C.6 – Documentation of teaching recipient on care of and examples of misuse/neglect of equipment.
- 1303.2.A.1.a – Updated to allow 6 months for face-to-face and prescription.
- 1303.2.A.3 and B.3. – Added definition of invoice requirements and clarification of required records.
- 1303.3 and 1303.5.A – Modifier and physician order clarification and added no solicitation
- 1303.5.C – Recipient exclusive use and place of service required for deliveries



MSM 1300 Proposed Updates

Appendix A – Non-covered services and Appendix B page 1– Reiterated qualifications, convenience/comfort purposes not allowed, duplicate services and exception clarifications.

Appendix B - Cardioverter defibrillator policy added

- updated SGD trial period, diabetic services HCPCs, Gait trainer notes/HCPCs.
- Positioning seats, power elevating leg rests, cranial remolding devices policy added
- Bi-PAP and C-PAP sleep study for hospital discharge clarified, Pickwickian syndrome added, compliance spelled out
- Non-invasive Ventilator policy added
