1. Overview and Methodology

Overview

Under the contract for external quality review (EQR), the State of Nevada Department of Health and Human Services, Division of Health Care Financing and Policy (DHCFP) requested that Health Services Advisory Group, Inc. (HSAG), conduct a network adequacy validation (NAV) of the Medicaid provider network for all managed care organizations (MCOs) and the dental benefits administrator (DBA)/prepaid ambulatory health plan (PAHP) during state fiscal year (SFY) 2022. According to the federal regulations for managed care released in May 2016, the activity related to Title 42 of the Code of Federal Regulations (42 CFR) §438.358(b)(1)(iv), validation of network adequacy, shall commence no later than one year from the issuance of the associated EQR protocol. In preparation for the release of the protocol, in SFY 2019 HSAG collaborated with DHCFP to create a provider crosswalk file that has been used in subsequent NAV activities. The provider crosswalk serves as the MCOs' and DBA's guidance for classifying all ordering, referring, and servicing providers contracted to provide care into selected provider categories. Consistent classification is vital for the validation of network adequacy to ensure all providers are classified with the same definitions. HSAG worked with DHCFP to update the provider crosswalk in SFY 2022 to reflect recent changes and additions to provider categories.

The providers included in the NAV comprised all ordering, referring, and servicing providers contracted to provide care through one of Nevada's Medicaid MCOs, the DBA, or all providers contracted through Nevada's Medicaid Fee-for-Service (FFS) network.

The MCOs and DBA, collectively referred to as "plans," included in the NAV are listed below:

- Anthem Blue Cross and Blue Shield Healthcare Solutions (Anthem)
- Health Plan of Nevada (HPN)
- Molina Healthcare of Nevada, Inc. (Molina of Nevada)
- SilverSummit Healthplan, Inc. (SilverSummit)
- LIBERTY Dental Plan of Nevada, Inc. (LIBERTY)

Out-of-state providers were included in the NAV if they practice in one of the Nevada's Medicaid catchment areas listed in Appendix A. Many of these providers are geographically closer to recipients living near the Nevada border than some providers practicing within the state. Contracted providers in these catchment areas are subject to the same requirements as in-state providers regarding covered services and prior authorization requirements.

The NAV for SFY 2022 included network capacity and geographic distribution analyses conducted after the MCOs and DBA identified provider categories by using their respective provider crosswalks HSAG developed in conjunction with DHCFP. HSAG also conducted network capacity analyses for the FFS population by applying the MCO provider crosswalk to DHCFP's provider data to classify providers.




Figure 1—SFY 2022 Network Adequacy Tasks

Figure 1 defines HSAG's three main phases for the SFY 2022 network adequacy tasks. HSAG conducted the NAV analyses for the managed care members residing in urban Clark and Washoe counties, as well as for members residing statewide. HSAG's analyses for the FFS population included FFS members residing statewide.

Methodology

In collaboration with DHCFP, HSAG collected and reviewed submitted data and ensured provider categories were acceptable for NAV inclusion and final report generation. At a minimum and as applicable, analyses and templates included provider categories aligned with DHCFP's SFY 2022 managed care provider crosswalks and the minimum provider categories identified in 42 CFR §438.68 of the federal network adequacy standard requirement. These categories represent common types or specialties of healthcare providers generally needed within a Medicaid population. The SFY 2022 NAV activity contained the following analyses:

- Network Capacity Analysis: HSAG compared the number of providers associated with each of the MCOs, the DBA, and the FFS provider networks relative to the number of enrolled members. This provider-to-member ratio (provider ratio) represents a summary statistic used to highlight the overall capacity of a provider network to deliver services to Medicaid members.
- **Geographic Network Distribution Analysis:** HSAG evaluated the geographic distribution of the providers relative to member populations. For each MCO and the DBA, HSAG calculated the percentage of members within predefined access standards and the average time and distance to the nearest three providers.



The analysis completed for each provider network is listed in Table 1-1.

Data Collection

HSAG worked with DHCFP to outline data requirement documents that were submitted to each of the plans and to DHCFP. HSAG requested all provider and member information for those who were actively enrolled as of March 1, 2022. These documents, as outlined below, provided detailed instructions on data submission requirements:

- **The Plans:** HSAG provided detailed data requirements that defined which provider information should be submitted, as well as a provider crosswalk to ensure consistency in classifying providers across all plans.
 - Provider Data
 - The plans provided key data elements for each provider, such as unique provider identifier, enrollment status, provider specialty, provider taxonomy, and provider address information. The plans mapped providers to selected provider categories in alignment with the provider crosswalk to identify the provider category.
- **DHCFP:** HSAG provided detailed data requirements that defined which provider and member information should be submitted.
 - Provider Data
 - DHCFP provided key data elements for each provider, such as unique provider identifier, enrollment status, provider specialty, provider taxonomy, and provider address information. This information allowed HSAG to classify the FFS providers based on the provider crosswalk that was supplied to the plans.
 - Member Data
 - DHCFP provided key data elements for each member, such as enrollment and demographic information for members who were served by one or more MCO, DBA, or the FFS network.



Data Processing

HSAG cleaned, processed, and defined the unduplicated lists of providers, provider locations, and members for inclusion in the analysis. HSAG then standardized and geocoded all Medicaid member and provider files using Quest Analytics Suite Version 2022.1 software. For all analyses, adults were defined as those members aged 18 years or older, and children were defined as members younger than 18 years of age. Analyses for obstetrics and gynecology (OB/GYN) providers were limited to female members aged 18 years and older.

For each plan and the FFS network, the provider ratio was calculated using the number of unduplicated providers with service locations in the State of Nevada or within the Nevada Medicaid catchment areas relative to the unique number of members. To identify unique providers, HSAG deduplicated the provider files by National Provider Identifier (NPI) and provider category. For the time-distance analysis, HSAG included every location listed for a given provider in the plan's or the FFS provider network.

Network Capacity Analysis

To assess the capacity of the plans and the FFS provider network, HSAG calculated the ratio of the number of providers by provider category (e.g., primary care providers [PCPs], cardiologists) to the number of members. The provider ratio represents a summary statistic used to highlight the overall capacity of the plans or FFS provider network to deliver services to Medicaid recipients. A larger number of providers for a given number of members suggests greater network access since more providers are available to render services to individuals. Provider counts for this analysis were based on counts of distinct providers and not distinct provider locations. All study results were calculated at the statewide and county level.

The Plans

Table 1-2 shows the provider categories used to assess the MCOs' and DBA's compliance with the provider ratio standards in the MCO and DBA contracts. The results for additional provider types outlined in the provider crosswalk were included in the provider ratio analyses for reference. Since DHCFP does not maintain provider ratio standards for these additional categories, the MCOs' and DBA's compliance cannot be assessed. HSAG provided these results for informational purposes only.

* If the PCP practices in conjunction with a healthcare professional, the ratio is increased to one full-time equivalent (FTE) PCP for every 1,800 members.



Fee-for-Service

HSAG calculated the provider ratio for each provider category defined below in Table 1-3 for the FFS network. The provider ratio measured the number of providers by provider category (e.g., PCPs, inpatient hospitals) relative to the number of members. A lower provider ratio suggests the potential for greater network access since a larger pool of providers is available to render services to individuals. Provider counts for this analysis were based on unique providers and not provider locations. Provider ratios are reported but are not compared to a provider ratio standard.

Geographic Network Distribution Analysis

The second dimension of this study evaluated the geographic distribution of providers relative to MCO or DBA members. While the previously described network capacity analysis identified the degree to which each MCO's or the DBA's provider network infrastructure was sufficient in the number of providers across a variety of specialties, the geographic network distribution analysis evaluated whether the number of provider locations in an MCO's or the DBA's provider network was appropriately distributed for the plan's Medicaid population.

To provide a comprehensive view of geographic access, HSAG calculated the following two spatially derived metrics for the provider categories identified in the provider crosswalks:

• Percentage of members within access standards listed in the MCO and DBA contracts: A higher percentage of members meeting access standards indicates a better geographic distribution of MCO providers relative to Medicaid members.



• Average travel distances (driving distances in miles) and travel times (driving times in minutes) to the nearest three providers: A shorter driving distance or travel time indicates greater accessibility to providers since members must travel fewer miles or minutes to access care.

HSAG additionally calculated the duration of travel time and physical distance between a member's address and their first-, second-, and third-nearest providers for all provider categories identified in the provider crosswalks. HSAG stratified all results by plan and county.

Table 1-4 shows the provider categories used to assess the plans' associated time and distance access standards. Additional provider types outlined in the provider crosswalk were included in the provider ratio analyses and average travel time analyses. The full list of provider types shown in the provider crosswalk are listed in Appendix B.

Analytic Considerations

Various factors associated with the SFY 2022 NAV may affect the validity or interpretation of the results presented in this report, including, but not limited to:

- Provider ratios represent high-level, aggregate measures of capacity based on the number of unique providers relative to members. This raw count of capacity does not account for the individual status of a provider's panel (i.e., accepting or not accepting new patients) or how active the provider is in the Medicaid program. Further, it is likely that a portion of providers are contracted to provide services for all four MCOs. As such, the provider ratio represents a potential capacity and may not directly reflect the availability of providers at any point in time.
- NAV findings are associated with the plans' network data files for all providers active with each plan as of March 1, 2022, and are contingent on the quality of member and network data supplied by DHCFP and the plans, respectively. Any substantial and systematic errors in plans' provider data may compromise the validity and reliability of the SFY 2022 NAV results.
 - NAV results do not reflect plans' network changes implemented since March 2022.
 - HSAG and DHCFP directed the plans to use the approved network crosswalk when preparing network data. As the crosswalk was initially developed based on the plans' SFY 2020 network



data and updated in SFY 2022, a lack of compliance identified during the NAV analyses may reflect either a lack of contracted providers for the specified plan, or a plan's challenges in aligning internal network data with the approved network crosswalk categories.

- It was beyond the SFY 2022 NAV scope to evaluate the accuracy of the plans' network data or the FFS network data against an external standard (e.g., using telephone survey calls to verify the accuracy of network locations, contact information, new patient acceptance, or services offered).
- When evaluating the results presented in this report, note that provider data supplied by the plans do not include providers contracted with the plans under limited use contracts or single case agreements. A larger number of members may have access to providers if plans contract with selected providers under these limited use agreements versus standard contract agreements.
- The time and distance calculations reflected in the SFY 2022 NAV represent a high-level measurement of the similarity of the geographic distribution of network locations relative to members. These raw, comparative statistics do not account for the individual status of a provider's panel (i.e., accepting or not accepting new patients) at a specific location or how active the provider location is in the Nevada managed care program.
 - It is likely that some network locations are contracted to provide services for more than one MCO. As such, time and distance results highlight the geographic distribution of a provider network for all available network locations noted in the plans' network data files without considering potential barriers to new patient acceptance or appointment availability at individual service locations.
 - Prior to calculating time and distance results, HSAG geocoded the provider and member data to assign latitude and longitude values to each record. A limited percentage (i.e., less than 1 percent) of records could not be geocoded primarily due to invalid ZIP Codes or missing ZIP Codes from the data and were subsequently excluded from NAV analyses.
 - The member address data may not always reflect a member's place of residence (e.g., use of post office boxes), or be identifiable with mapping software (e.g., addresses reflecting local place designations, rather than street addresses). While mapping software may assign members to geographic coordinates, these coordinates may not align with the member's exact residential location for records that do not use a standard street address.
 - When evaluating the results of these analyses, it is important to note that the reported average drive time may not mirror driver experience based on varying traffic conditions. Instead, average drive time should be interpreted as a standardized measure of the geographic distribution of providers relative to Medicaid members; the shorter the average drive time, the more similar the distribution of providers is relative to members. Current drive times are estimated by Quest Analytics based on the following drive speeds: urban areas are estimated at a drive speed of 30 miles per hour, suburban areas are estimated at a drive speed of 45 miles per hour, and rural areas are estimated at a drive speed of 55 miles per hour.



2. NAV Findings—MCO

HSAG calculated the ratio of providers to members for each MCO and for Clark and Washoe counties to assess the capacity of Nevada's provider network and to evaluate compliance with the network adequacy standards stated in the MCO contracts. This provider ratio analysis is coupled with a geographic network distribution analysis to identify areas of provider need and to compare the provider networks maintained by each MCO.

Eligible Member Population

Table 2-1 displays the number of eligible members for each MCO. For all analyses, adults were defined as those members aged 18 years or older, and children were defined as members younger than 18 years of age. Analyses for OB/GYNs were limited to female members aged 18 years and older. Statewide population counts include members who reside in Clark and Washoe counties plus managed care members who reside in other Nevada counties.

Member populations across all MCOs and member categories were similar across Clark and Washoe counties, with approximately 85 to 90 percent of members residing in Clark County and approximately 10 to 15 percent of members residing in Washoe County. Additionally, member populations across all MCOs were similar, with roughly 55 to 60 percent of all members statewide being adults (aged 18 years and older), and roughly 45 percent of all members statewide being children (aged 17 years and younger). For all MCOs, approximately one-third of all members were adult females. Across the MCOs, **Molina of Nevada** had the smallest total population size statewide (123,026 members) and **HPN** had the largest (208,596 members).

*Statewide count incorporates all Nevada counties included in the DHCFP member file submission and members enrolled with the MCO or DBA as of March 1, 2022. Therefore, if managed care members reside outside of Clark and Washoe counties, then the statewide count may be higher than the sum of those counties. Managed care members may have addresses outside of Clark and Washoe counties for a variety of reasons, possibly including members who moved mid-month who have not yet been disenrolled or the data received may not reflect the member's current residential address.

**Adult females are a subset of adults; therefore, the total population contains the sum of adults and children and not the sum of all categories displayed.

Network Capacity Analysis

Provider ratios were calculated using the member populations described in Table 2-1. Provider ratios for adult physician specialists were calculated using the adult member population only. Similarly, provider ratios for child physician specialists were calculated using the child member population only. The provider ratios for OB/GYN was based on the adult female population only.

When interpreting the provider ratio results, it should be considered that not all members require routine care by all provider types; therefore, thresholds requiring fewer providers for a given number of members may be appropriate for certain physician specialists. Additionally, ratio results were not adjusted to account for the distribution of demographic and clinical member characteristics represented within each MCO. An MCO with a greater number of members with comorbidities or specific conditions may require a greater number of physician specialists. Lastly, the provider ratio standards were limited to the broad categories of PCPs and physician specialists, not to specific specialties within those categories. For example, an MCO must maintain a network of one physician specialist to 1,500 members but is not required to maintain that ratio for each identified specialty groups are shown for informational purposes, but only the standards shown for provider categories in Table 1-2 were assessed for compliance.

Table 2-2 through Table 2-21 present provider ratio analysis results by MCO, provider category, and county. These results include out-of-state providers who are within the catchment areas as members may travel outside the state for medical services. Provider ratios are a measure of provider capacity based on the number of providers in the MCO network and the number of Medicaid managed care members enrolled in the MCO. For example, in Table 2-2, **Anthem** has 1,372 PCPs, resulting in a ratio of one PCP for every 122 members in Clark County (i.e., 1:122). Provider types assessed to the provider ratio access standard are **bolded**. Assessed provider ratios shown in green indicate the provider ratio was in



compliance with the access standard, whereas provider ratios shown in red indicate the provider ratio was not in compliance with the access standard.

A comparison of results across MCOs for provider types that were compared to a provider ratio access standard is available in Appendix C.

Anthem Blue Cross and Blue Shield Healthcare Solutions

Table 2-2 through Table 2-6 display the provider ratios for **Anthem**. **Anthem** met the required provider ratio for all provider categories assessed in both Clark and Washoe counties. Across all provider categories, Washoe County consistently had lower provider ratios, which may be the result of having a smaller member population compared to Clark County.

As shown in Table 2-2, **Anthem** reported providers for all PCP and PCP Extender provider categories and met the required provider ratios for both in Clark and Washoe counties. Statewide, **Anthem** reported 1,372 PCPs and 1,795 PCP Extenders, resulting in provider ratios of 1:140 and 1:59, respectively.

Overall, **Anthem** met the provider ratio access standard for physician specialists across Clark and Washoe counties, as shown in Table 2-3. Statewide, there was one provider to every 129 members. **Anthem** did not report any pediatric physician specialists for Dermatologist, Otolaryngologist, and Physical Medicine Specialist in its provider network.

Geographic Network Distribution Analysis

Geographic network distribution analyses assess whether members experience undue burden related to either excessive travel time or distance required to reach the nearest provider. The State of Nevada has established contract access standards by provider category for the maximum allowable distance a member must travel to receive care (previously reported in Table 1-4). Time and distance percentages were calculated using the member populations described in Table 2-1. Results for primary care, adults and for adult physician specialists were calculated using the adult member population only. Results for Pediatrician and child physician specialists were calculated using the child member population only, and the results for OB/GYN were based on the adult female population only. Some access standards (i.e.,



Primary Care, Adults and Hospital, All) were limited to the broad categories of adult PCPs and hospitals, respectively, not to specific specialties within those categories. For example, an MCO must maintain a network of 100.0 percent of members within 10 miles or 15 minutes for Primary Care, Adults but is not required to maintain that access standard for each identified PCP, Adult category (e.g., Family Practitioner).

Table 2-22 through Table 2-37 list the percentages of members within the contract standards for each provider type by MCO, provider category, and county. Like the network capacity analysis, these results include out-of-state providers located within the Nevada Medicaid catchment areas as members may travel outside the state for medical services. Provider types assessed to the provider ratio access standard are **bolded**. Assessed results shown in green indicate that the percentage of members within the access standard was in compliance, and percentages shown in red indicate a result of less than 99.0 percent.

Additional detailed information on the travel time and travel distance to the nearest three providers for all providers included in the provider crosswalk as well as a comparison of results across MCOs is available in Appendix C.

Anthem Blue Cross and Blue Shield Healthcare Solutions

Table 2-22 through Table 2-25 display the time and distance results for **Anthem**. Overall, **Anthem** met the access standard in Washoe County for Endocrinologist, Pediatric, Infectious Disease, Pediatric, and QMHP, Pediatric. Although **Anthem** did not meet the 100.0 percent access standard in Clark County, for most provider categories, greater than 99.0 percent of members were within the access standard.

As shown in Table 2-22, more than 99.0 percent of members residing in Clark and Washoe counties were within the access standard for Primary Care, Adults and Pediatrician. However, less than 99.0 percent of members in Washoe County had access to an OB/GYN within 10 miles or 15 minutes.

Table 2-30 through Table 2-33 display the time and distance results for **Molina of Nevada**. Although **Molina of Nevada** did not meet the access standard for any provider category in Clark or Washoe counties, greater than 99.0 percent of members who reside in Clark County had access to most PCP categories assessed against the standard, except for OB/GYN. Additionally, greater than 99.0 percent of members residing in Clark County were within the access standard for all physician specialist categories, all behavioral health provider categories, and all facility-level provider categories. Greater than 99.0 percent of members residing in Washoe County had access to Adult PCP; most physician specialist categories, except for Rheumatologist, Pediatric; all behavioral health provider categories; and all facility-level provider categories, except for Dialysis/ESRD Facility.

As shown in Table 2-30, greater than 99.0 percent of members had access to Primary Care, Adults within the access standard in both Clark and Washoe counties. Less than 99.0 percent of members had access to OB/GYN within the access standard for both Clark and Washoe counties. Greater than 99.9 percent of members who reside in Clark County had access to a pediatrician within the access standard, whereas less than 99.0 percent of members in Washoe County had access within the access standard.

Overall, **SilverSummit** met the access standard for three of the six behavioral health provider categories for members residing in Clark County, and six of the nine physician specialist categories and one of six behavioral health provider categories assessed for members residing in Washoe County. Greater than 99.0 percent of members residing in Clark County had access to most provider categories within the access standard, except for OB/GYN. Greater than 99.0 percent of members residing in Washoe County had access to nearly all provider categories within the access standard, except for OB/GYN, Pediatrician, Rheumatologist, Pediatric, and Psychologist, Pediatric.

As displayed in Table 2-34, greater than 99.0 percent of members residing in Clark and Washoe counties had access to Primary Care, Adults within the access standard. In both Clark and Washoe counties, less than 99.0 percent of members had access to an OB/GYN within the access standard, and greater than 99.9 percent of members residing in Clark County had access to a pediatrician within the access standard.

3. NAV Findings—DBA/PAHP

HSAG calculated the ratio of providers to members for the DBA, **LIBERTY**, to assess the capacity of Nevada's provider network and to assess compliance with the network adequacy standards stated in the DBA contract. This provider ratio analysis is coupled with a geographic network distribution analysis to identify areas of provider need and to compare the provider networks maintained by **LIBERTY**.

Eligible Member Population

Table 3-1 displays the member population counts, by county, for members enrolled with **LIBERTY**. For all analyses, adults were defined as those members aged 18 years or older, and children were defined as members younger than 18 years of age. Statewide population counts include members who reside in Clark and Washoe counties plus managed care members who reside in other Nevada counties.

Most **LIBERTY** members resided in Clark County (approximately 90 percent) compared to Washoe County (roughly 10 percent). Additionally, member categories across Clark and Washoe counties were also similar, with roughly 55 percent of all members being adults (aged 18 years and older), and approximately 45 percent of all members being children (aged 17 years and younger).

Network Capacity Analysis

Provider ratios were calculated using the member populations described in Table 3-1. Provider ratios for adult dental specialists were calculated using the adult member population only; similarly, provider ratios for child dental specialists were calculated using the child member population only.

Similar to interpreting the MCO provider ratio results, it should be considered that not all members require routine care by all dental provider types; therefore, requiring fewer providers for a given population may be appropriate for certain dental specialists. Additionally, ratio results were not adjusted to account for the distribution of demographic and clinical member characteristics represented within the DBA. Lastly, the provider ratio standards were limited to the broad categories of dental primary care provider and dental specialists, not to specific specialties within those categories. For example, the DBA must maintain a network of at least one dental specialist for every 1,500 members but is not required to



maintain that ratio for each identified specialty category (e.g., Endodontist). For the purposes of this report, ratios for the individual specialty groups are shown for informational purposes, while only the standards for provider categories shown in Table 1-2 were assessed for compliance.

Table 3-2 presents provider ratio analysis results, which includes out-of-state providers within the Nevada Medicaid catchment areas since members may travel outside the state for dental services. Provider types assessed to the provider ratio are **bolded**. Assessed provider ratios shown in green indicate the provider ratio was in compliance with the access standard, whereas provider ratios shown in red indicate the provider ratio was not in compliance with the access standard.

As shown in Table 3-2, **LIBERTY** met the provider ratio access standard for Dental Primary Care Providers in both Clark and Washoe counties, as well as for members residing statewide. **LIBERTY** did not meet the 1:1,500 provider ratio standard for Clark County or statewide for Dental Specialists but did meet the ratio standard for Washoe County. **LIBERTY** did not report any Dental Therapists in its provider network. Across all provider categories, Washoe County consistently had lower provider ratios, which may be the result of having a smaller member population compared to Clark County.

Geographic Network Distribution Analysis

Table 3-3 lists the percentages of members within the contract standards for each provider category and county. Similar to the network capacity analysis, results include out-of-state providers who are within the Nevada Medicaid catchment areas as members may travel outside the state for medical services. Provider types assessed to the provider ratio access standard are **bolded**. Assessed results shown in green indicate that percentage of members within the access standard was in compliance, and percentages shown in red indicate a result of less than 99.0 percent.

Additional detailed information on travel times and travel distances to the nearest three providers for all providers included in the provider crosswalk is available in Appendix D.

As shown in Table 3-3, **LIBERTY** did not meet the access standard for any provider category assessed; however, greater than 99.0 percent of members had access to all dental providers across Clark County. For members residing in Washoe County, greater than 99.0 percent of members had access to nearly all dental providers assessed, except for Public Health Endorsed Dental Hygienist and Prosthodontist.

4. NAV Findings—Fee-for-Service

Eligible Member Population

Table 4-1 displays statewide member population counts for members enrolled in the FFS network. Member counts at the county level are displayed in Appendix E. For all analyses, adults were defined as members aged 18 years or older, and children were defined as members younger than 18 years of age. Analyses for OB/GYNs were limited to female members aged 18 years and older.

Statewide, approximately 74 percent of all FFS members were adults (aged 18 years and older) and 26 percent were children (aged 17 years and younger). Roughly 42 percent of all FFS members statewide were adult females.

Network Capacity Analysis

Provider ratios were calculated using the member populations described in Table 4-1. Provider ratios for adult physician specialists were calculated using the adult member population only. Similarly, provider ratios for child physician specialists were calculated using the child member population only, and provider ratios for OB/GYNs were based on the adult female population only.

When interpreting provider ratio results, it should be considered that not all members require routine care by all provider types; therefore, thresholds requiring fewer providers for a given number of members may be appropriate for certain physician specialists.



Table 4-2 displays provider ratios for the FFS network. Statewide, the provider ratio for PCPs was 1:42 and the provider ratio for PCP Extenders was 1:36. There were 69 inpatient hospitals and 541 pharmacies reported in the FFS provider network, resulting in a provider ratio of 1:2,246 and 1:422, respectively. Provider ratios by county are presented in Appendix E.

Conclusion

The Nevada SFY 2022 NAV findings indicate a wide provider network for the MCOs, DBA, and the FFS networks. Generally, there is a large number and array of providers across most provider categories per member and, with few exceptions, greater than 99.0 percent of members have access to these providers within the geographic accessibility requirements. However, opportunities for improvement surrounding pediatric specialties still exist.

The network capacity analysis suggests that the MCOs are meeting the provider ratio access standards for all provider categories assessed across both Clark and Washoe counties. Clark County consistently had higher provider ratios, which may be the result of having a larger member population compared to Washoe County. For all MCOs, PCP Extenders had the lowest ratios, indicating a greater network capacity for members in comparison to PCPs and physician specialists. For members statewide and for members in Clark and Washoe counties, **SilverSummit** had the lowest ratios for PCPs, PCP Extenders, and physician specialists, although **HPN** reported the greatest number of PCPs and physician specialists.

The geographic network distribution analysis measures the MCOs and DBA against minimum geographic accessibility requirements for all members. Although ensuring that 100.0 percent of members have access within the contractual defined access standard is challenging, the plans generally maintained a geographic accessible network, with greater than 99.0 percent of members residing within the time or distance access standards for most provider categories. None of the MCOs met the standard for PCPs in either Clark or Washoe counties; however, greater than 99.0 percent of adult members in Clark and Washoe counties across all MCOs had access to an adult PCP within the access standard. Greater than 99.0 percent of members who reside in Clark County for both **Anthem** and **HPN** had access to an OB/GYN within the access standard, whereas all MCOs had less than 99.0 percent of members within the access standard for OB/GYN in Washoe County. In Clark County, greater than 99.0 percent of members across all MCOs had access to a pediatrician within the access standard, whereas only **Anthem** had greater than 99.0 percent of members with access standard in Washoe County.

Although none of the MCOs met the standard for physician specialists for members residing in Clark County, greater than 99.9 percent of these members had access to all specialists within the access standard. In Washoe County, **HPN** met the access standard for seven of the nine physician specialist categories assessed, **SilverSummit** met the access standard for six of the nine physician specialist categories assessed, and **Anthem** met the access standard for two of nine physician specialist categories assessed. Across all MCOs, 0.0 percent of members who reside in Washoe County had access to a pediatric rheumatologist.

Access to care for behavioral health providers was generally high across all MCOs, with 99.9 percent or more of members having access to care within the access standard for nearly all behavioral health providers. **HPN** met the access standard for behavioral health providers in Clark and Washoe counties



for four of the six provider categories, whereas **SilverSummit** met the access standard across both counties for one provider category. **Anthem** and **HPN** met the access standard for one provider category in Washoe County, and **SilverSummit** met the access standard in Clark County for two provider categories. Although no MCOs met the access standard for Psychologist, greater than 99.0 percent of members across all MCOs and counties were within the access standard. Both **Anthem** and **SilverSummit** had 0.0 percent of members who reside in Washoe County within the access standard for Psychologist, Pediatric.

Similarly, access to care for facility-level providers was generally high across all MCOs, with 99.9 percent or more of members having access to care within the access standard for nearly all facility-level provider categories. Although **HPN** met the access standard in Washoe County for only one facility-level provider category (Dialysis/ESRD Facility), all MCOs had greater than 99.0 percent of members in Clark and Washoe counties within the access standard for all Hospitals, Pharmacy, and Psychiatric Inpatient Hospital.

LIBERTY met the provider ratio standard for Dental Primary Care Providers in both Clark and Washoe counties and for dental specialists in Washoe County; however, **LIBERTY** did not meet the provider ratio access standard for dental specialists in Clark County. This is consistent with the geographic network distribution analysis, where although **LIBERTY** did not meet the access standard for any provider category, greater than 99.0 percent of members across Clark County had access to all provider types within the access standard. In Washoe County, greater than 99.0 percent of members had access within the access standard for all provider types, except for Public Health Endorsed Dental Hygienist and Prosthodontist, where 0.0 percent of members had access.

Statewide, the number of members in the FFS network per provider was low, with one PCP per every 42 members and one PCP extender per every 36 members. Although this suggests the robustness of the FFS network, these results should be interpreted with care since they do not indicate a provider's capacity and because a geographic network distribution analysis was outside of the scope of work for this activity.

Promising Practices and Opportunities for Improvements

Based on the results and conclusions presented in this report, HSAG recommends the following for DHCFP and the MCOs and DBA to strengthen the Medicaid managed care provider networks and FFS network to ensure members' access to healthcare services:

• As provider ratios and geographic distribution represent the potential capacity and distribution of contracted providers and may not directly reflect the availability of providers at any point in time, DHCFP should consider using appointment availability and utilization analyses to evaluate providers' availability. Future studies may incorporate encounter data or secret shopper telephone survey results to assess members' utilization of services, as well as potential gaps in access to care resulting from inadequate provider availability.



- In addition to assessing the number, distribution, and availability of providers, DHCFP should review patient satisfaction survey results and grievance and appeals data to evaluate the degree to which members are satisfied with the care they have received.
- DHCFP should conduct an in-depth review of provider categories in which each plan did not meet either provider ratio or time and distance access standards, with the goal of determining whether or not the failure of the plan to meet the contract standard(s) was the result of a lack of providers or an inability to contract with providers in the geographic area. Future analyses should evaluate the extent to which the plans have requested exemptions from DHCFP for provider categories in which providers may not be available or willing to contract with the MCO(s) or DBA.
- Provider ratios were calculated using all providers who were enrolled with the plans and the FFS network as of March 1, 2022; however, these calculations do not consider a provider's panel capacity or if they are accepting new patients. DHCFP should consider calculating provider ratios that adjust for the number of plans the provider is contracted with or calculating provider ratios to those providers who are actively seeing Medicaid enrolled members by using encounter data.
- Provider categories that do not have an access standard were included in this NAV analysis and some results were shown for informational purposes only. DHCFP should consider developing access standards for these provider categories, which will allow DHCFP to better assess the breadth of each plan's provider network.
- DHCFP should work with the MCOs to expand contracting efforts for Rheumatologist, Pediatric and Psychologist, Pediatric in Washoe County. Additionally, DHCFP should work with **LIBERTY** to expand contracting efforts for dental specialists.
- DHCFP should consider conducting further analyses for the FFS provider network by performing network capacity analyses on additional provider types or conducting a geographic distribution analysis. Although there are no standards to assess the FFS network against, DHCFP could determine the average time and distance it takes for members to access care to the nearest three providers by county or examine the average time traveled to active providers.

Appendix C. Detailed MCO Findings

Appendix C presents detailed results for the MCO geographic distribution analysis. For each county and MCO, the average time and distance for members to the nearest three providers is displayed. Additionally, results from the network capacity analysis and geographic network distribution analysis are compared across MCOs.

Average Travel Distances and Travel Times

The average travel time and travel distance from the member to the nearest three providers for each MCO, provider category, and county is presented below in Table C-1 through Table C-20. Results include out-of-state providers who are within the Nevada Medicaid catchment areas since members may travel outside the state for medical services. HSAG calculated the duration of travel time and physical distance between the addresses of the members and their nearest three providers for all provider categories identified in the provider crosswalk. A shorter driving distance or travel time indicates greater accessibility to providers since members must travel fewer miles or minutes to access care.

Appendix F. Responses From the MCOs and DBA

Each plan given an opportunity to respond and provide feedback on a draft version of the NAV report. Responses from each MCO and the DBA are listed below.

NAV Responses—MCO

Anthem Blue Cross and Blue Shield Healthcare Solutions

Anthem's submission to HSAG defined pediatric hospitals interchangeably with Children's hospitals or inpatient hospitals exclusively serving patients predominately under 18 and enrolled with children's hospital taxonomy codes. However, after further clarification, Anthem confirms we are actually contracted with 3 Pediatric Hospitals within Clark County, NV, 1 Pediatric Hospital in Washoe County, NV. Anthem agrees to classify [Hospital name redacted], [Hospital name redacted], [Hospital name redacted] and [Hospital name redacted] hospitals as Inpatient Hospital and a Pediatric Hospital under both PF150–Inpatient Hospital, and PF151–Pediatric Hospital in Clark and Washoe Counties respectively.

Anthem would also like to share that we have 2 Pediatric Psychologists in Washoe County, NV. [Provider name redacted] and [Provider name redacted] are both Pediatric Psychologists part of the Anthem contracted provider network.

Health Plan of Nevada

Research has demonstrated that there is not a pediatric rheumatologist in Washoe County. This is the reason the pediatric rheumatologist category reflects a gap in network coverage for Medicaid members. Therefore, expanding contracting efforts for this specialty category in Washoe County is not a viable recommendation. Currently, there is only one pediatric rheumatologist in the State of Nevada, who practices in Las Vegas. Telehealth options to expand coverage for pediatric rheumatology could be considered, but would require legislative flexibilities in telehealth regulations to allow physicians licensed in other states to render care in Nevada.

Molina Healthcare of Nevada, Inc.

- Molina continuously monitors our network to create the broadest access to care and frequently adds new providers and specialists to the network. In some cases, Nevada lacks certain specialty providers creating a challenge to add those groups into the network.
- Molina is contracted with a Pediatric Hospital in Clark County as of 3/15/22. The contracted Pediatric Hospital was not reflected in this NAV activity, as the study only included providers contracted as of 3/1/22.



• Molina uses the NV Active Provider State File supplied monthly from the State as our data source to verify Taxonomy codes. Molina is not currently aware of any providers who meet the provider category guidance for *Mental Health Nurse, Pediatric* based solely on taxonomy codes.

SilverSummit Healthplan, Inc.

• SilverSummit Healthplan has reviewed the Network Adequacy Validation report and is in agreement with the information reflected in this report. Where the state has defined deficiencies or opportunities, SSHP continually monitors the state report and actively outreaches to Medicaid enrolled providers for addition to our network.

NAV Responses—DBA

LIBERTY Dental Plan of Nevada, Inc.

- 1. LIBERTY is in the process of partnering with a Registered Dental Hygienist with a Public Health Endorsement in Northern Nevada.
- 2. LIBERTY has entered into partnerships with Truckee Meadows Community College (hygiene program) and UNLV (Dental school) to provide scholarships.
- 3. There is not a Prosthodontist in Northern Nevada with a Medicaid ID.
- 4. Nevada currently uses the same ratio for dental specialists and primary dental care providers. However, dental specialists are not considered primary care and do not hold a panel as primary dental care providers do. Nevada may want to consider using a different standard for dental specialists to reflect their capacity to accommodate a larger population similar to other medical subspecialities. For example, Pediatric Dentists 1:3,000, Endodontists 1:5,000, and Oral Surgeons 1:20,600 are used in another state's Medicaid program.
