NRS 422.2704 requires that, every four (4) years, the State of Nevada, Division of Health Care Financing and Policy (DHCFP) review the rate of reimbursement for each service or item provided under the State Plan for Medicaid to determine whether the rate of reimbursement accurately reflects the actual cost of providing the service or item. The DHCFP has established a yearly rate review schedule that is based on provider types and their assigned specialties. The schedule below only reflects the survey schedule and does not display any anticipated reports generated from the conclusions of the reviews. As such, the DHCFP reserves the right to amend the yearly schedule if deemed necessary. The survey schedule is divided by the number of codes per provider type, and not by number of providers. This is to help ensure that the analysis can be done in a timely manner. Additionally, while each provider type must be surveyed at least every four (4) years, some providers may be surveyed sooner.
