3. DOJ Settlement Agreement Update:

Presentation By: Stacie Weeks

Stacie informed working group members and the public that the U.S. Department of Justice (DOJ) settlement has been signed by the Governor's Office and the DOJ. This settlement is effective January 2, 2025. Stacie and Ann walked through the different sections of the agreement. There are 13 sections that outline all the requirements for the state to meet within five years. Stacie also explained that there is going to be an independent evaluator contracted through the State of Nevada and that will report back to the DOJ about the Children's Behavioral Health Transformation's work. The purpose of the agreement is to prevent children from being removed from their family home to obtain treatment for behavioral health conditions. Nevada is working to prevent children from unnecessarily entering inpatient settings and residential treatment facilities due to unmet behavioral health needs by building a stronger home- and community-based behavioral health system.

Stacie further explained that Nevada wants to ensure children with behavioral needs have the support they need to remain at home and in their communities whenever possible. We have a duty as a state to ensure that children with disabilities have access to a robust array of state funded behavioral health services to ensure community-based living.

Ann Jensen:

Ann explained the focus population that is defined in the Settlement Agreement, as well as that the state will be defining eligibility for services even more broadly than that definition. Additionally, the state is required to use a new Specialty Managed Care delivery system to deliver benefits to eligible youth. The intention is for this model to be unique and provide enhanced benefits and protections beyond standard Medicaid Managed care. We have a chance to design this delivery system to uniquely serve the population of youth in Nevada we seek to better serve. Ann also walked through how to read the settlement agreement, including a highlevel summary of each section and the State's path to compliance. While Medicaid is the leading agency for this effort, strong collaboration with sister agency and county partners, as well as the CBHT working group and other members of the public, will be crucial for the success of this transformation.

4. Working Group Representative Discussion:

James Lutz asked if the eligible members for the program based on the level of severity and being eligible for residential treatment

Leah Skinner asked if Nevada is including those children who are in juvenile detention who are under the FIAS services and can no longer apply for Katie Beckett.

Gwynneth Smith mentioned that if the child is not in custody and the child is residing in a detention center or they are living in the community they would meet the definition of the focus population

Dr. Christine Pebbles was introduced to the working group by Ann as the new Clinical Advisor for the Children's Behavioral Health Transformation.

Jake Wiskerchen stated his concern with the screen-all-children approach is we find either a) a lot of false positives or b) a lot of real positives that overwhelm an already overwhelmed system, which is something to be mindful of.

Lea Cartwright expressed less concerned with false positives in the screening and more concern with screening everyone and learning that we (Nevada) can't handle the needs of our children, but it is better to know the needs.

Dr. Santosha Veeramachaneni shared concern with not being able to provide services to positive screening kids as a potential stress/harm that the screening and positive result will bring to kids and families who then may not have the resources for treatment.

Rhonda Lawrence said training in high quality implementation of mental health practice takes an investment of time (unbillable/non-reimbursable), quality regular consistent clinical supervision/consultation/coaching, and development of train the trainer models.

5. Public Comment:

Karen Thatcher asked what happens when the youth is no longer eligible for these services when they turn 21 (or 26 if involved in foster care)

Dana Walburn noted it would be great to include NDE in the interagency and there are a lot of behavioral health services occurring in schools including prevention and behavioral health screening.

Jessica Goichoechea-Paris said if the state uses the CANS assessment then ensuring discussion on reimbursement would be important for providers.

Dana Walburn said many districts are using the SSRI-E/Systematic screening as a universal screener.

Jessica Goichoechea-Parise asked how mobile crises response team policy changes and input will occur, and whether county teams are included.

Karen Thatcher asked whether meeting materials could be shared ahead of time and whether the meeting could be extended beyond an hour.

Dr. Takesha Cooper raised concerns regarding provider shortages for these children's behavioral health services. She emphasized the need for a workforce that is well trained in evidence based practices, such as cognitive behavioral therapy and dialectical behavioral therapy. She thinks that having a Center of Excellence is a strong idea to address some of these concerns.
