#### Dental vs. Medical Visits

According the Survey of Income and Program Participation (SIPP), respondents were much less likely to visit a dentist than a medical provider.

58.7 percent reported at least one dentist visit in the previous 12 months, compared to 72.7 percent of the population who reported at least one medical provider visit.

#### **Endodontics Defined**

- Endodontics is the branch of dentistry concerning dental pulp and tissues surrounding the roots of a tooth.
- Endodontic procedures, include root canal treatment, endodontic surgery and special procedures to save teeth after traumatic dental injuries.
- Endodontists become specialists by completing two or more years of advanced training in endodontics following dental school.

- Explore the lack of endodontic providers accepting Medicaid recipients
- Examine issues and causes
- Identify potential solutions

How can DHCFP ensure available endodontic benefits are accessible?





- Number of requests have increased over a one-year period.
- Dental policy staff is only aware of cases escalated by providers or parents to the Division. It is likely many are not escalated and children suffer.
- Some parents paid providers out of pocket, when they should have been able to get coverage.
- If untreated, children lose teeth.



- Fee-For-Service (FFS)Options
  - Only Option Non-Emergency Transportation (NET) to Las Vegas
- Dental Benefit Administrator (DBA) options
  - Out-of-Network Providers
  - Single Case Agreements
  - Ability to increase reimbursement beyond the established rate



#### Potential Solutions Explored Thus Far

	Possible Solution	Issue
	Healthy Smile/Healthy Child – providers serve pro bono. Limited capacity	Requires an access fee – DHCFP does not have a mechanism to pay unless providers are enrolled
	Federal Qualified Health Centers	Dental services are limited and only offered at three of 40 locations
	Contact Endodontists to build FFS network	Policy staff has used provider directories to contact endodontists listed
	Offer continuing education unit credit (CEU) for dentists to participate in a vital pulp therapy course	Long term solution for "simple" cases
