# Chapter Wide Changes



### Name/Term Changes

- School Based Child Health Services (SBCHS) is now School Health Services (SHS)
- School districts replaced with Local Education Agency (LEA)/ State Education Agency (SEA)
- Parent replaced with Legally Responsible Individual (LRI)



### Removal of IEP Requirement

 Most IEP language has been removed from the chapter and been replaced with Plan of Care (POC).

- Added POC language
- Added categories
  - Screening and Diagnostic Services
  - Treatment Services



# 2803.1A Screening and Diagnostic Services

- New Section
- Refers to Chapter 1500, Healthy Kids Program services that will now be covered in SHS
- Services that can be covered without a POC because they are screening and assessment services



#### 2803.1B Treatment Services

- New Section
- Refers to all services that will be included in SHS except those from 2803.1A Preventive and Diagnostic



### 2803.1C Coverage and Limitations

- Previously Section 2803.1A
- IEP development meeting changed to medical team conference
- Added the language to "3. Covered Services" to make it more inclusive of preventive services
- Rearranged services to match order described later in the chapter
- Updated the MSM Sections referenced



# 2803.1C Coverage and Limitations Added Covered Services

- Added to Covered Services (2803.1C3)
  - Screening, diagnostic, and treatment services
  - Mental Health and alcohol/substance abuse (replaced psychological counseling)
  - Personal Care Services (PCS)
  - Applied Behavior Analysis (ABA)
  - Dental services
  - Optometry services
  - Case management
  - Services delivered by telehealth



# 2803.1C Coverage and Limitations Changes to Non-Covered Services

#### Added

- Medical necessity requirement
- Reference to Ordering, Prescribing, Referring (OPR) section

#### Removed

- Dental or related services (these will now be covered)
- Treatment of obesity (this will now be covered)
- Any examination and laboratory tests for preventable diseases (this will now be covered)



# 2803.1D Provider Responsibility OPR and Under the Direction Of

- Previously Section 2803.1B
- Replaced "Medical or Treatment Services" Section with "Ordering, Prescribing, and Referring (OPR)" Section.
- The OPR Section was newly drafted



# 2803.1D Provider Responsibility POC and Medical Team Conference

- Replaced "Reserved for Future Use" Section with "Plan of Care (POC)" Section
- POC Section is newly drafted language
- Replaced "Individualized Education Program (IEP)" Section with "Medical Team Conference (with Interdisciplinary Team)" Section



# 2803.1D Provider Responsibility- Assessments, Records, and Non-Discrimination

- Removed Sections
  - IEP Assessment/Evaluation
  - Assessment
- Records Section- added statement that documentation must be completed as appropriate for the service being provided as detailed in the corresponding MSM chapter
- Made Non-Discrimination Section more general and reference back to MSM 100



# 2803.1D Provider Responsibility TPL and Katie Beckett Recipients

- Third-Party Liability (TPL)
  - Pay & Chase will only apply to IEP services
  - Medicaid will pay for services if the third-party insurance does not pay in a school setting
- Katie Beckett Recipients
  - Replaced Parental Notification and Consent Section
  - Parental Notification and Consent was removed as it is a Family Educational Rights and Privacy Act (FERPA) regulation not a Medicaid regulation.



#### 2803.1F Authorization Process

- Previously Section 2803.1D
  - POC serves as prior authorization
  - Added OPR refence



# 2803.2 Provider Qualifications Overview

 Licensed replaced with qualified as not all services require a license (example PCS).



# 2803.2 Provider Qualifications Details

- Added sections with qualification specification for each type of provider
  - A. Physician, Physician's Assistant (PA) & Advanced Nurse Practitioner Services
  - B. Mental Health and Substance Abuse
  - C. Nursing
  - D. Physical Therapy
  - E. Occupational Therapy
  - F. Speech Therapy and Audiology
  - G. PCS
  - H. ABA
  - I. Dental
  - J. Optometry
  - K. Case Management
  - L. Telehealth



# 2803.3 Screening, Diagnostic Services and Treatment

- Newly drafted language
- Based off MSM Chapter 1500, Healthy Kids Program



# 2803.4 Physician, Physician's Assistant & Advanced Nurse Practitioner Services

- Defined the list of covered services in 2803.4A as examples, not an exhaustive list
- Added new and established patient visited to covered services
- Added Limitations Section (2803.4B)



# 2803.5 Mental Health and Alcohol/Substance Abuse Services

- Replaced Psychological Counseling
- Based off MSM Chapter 400, Mental Health and Alcohol and Substance Abuse Services
- Added Limitations Section



### 2803.6 Nursing Services

- Added that nursing services must be under the order and supervision of a physician, or Advanced Practice Registered Nurse (APRN)
- Added Limitations Section (2803.6B)



### 2803.7 Physical Therapy Services

Added Limitations Section (2803.7B)



#### 2803.8 Occupational Therapy Services

Added Limitations Section (2803.8B)



# 2803.9 Speech Therapy and Audiology Services

Added Limitations Section (2803.9B)



### 2803.10 Audiological Supplies, Equipment, Medical Supplies and Other DME

Added Limitations Section (2803.10B)



### 2803.11 Personal Care Services (PCS)

 Newly drafted language based off MSM 3500, Personal Care Services Program, Nevada Revised Statues (NRS) Chapter 449 and the Division of Public and Behavioral Health (DPBH) requirements for PCS providers



### 2803.12 Applied Behavior Analysis (ABA)

- New service added to SHS
- Based off MSM Chapter 3700, Applied Behavior Analysis



### 2803.13 Dental

- New service added to SHS
- Based of MSM Chapter 1000, Dental



### 2803.14 Optometry

- New service added to SHS
- Based on MSM Chapter 1100, Ocular Services



### 2803.15 Case Management

- New service added to SHS
- Based on MSM Chapter 2500, Case Management



#### 2803.16 Telehealth

- New service added to SHS
- Based on MSM Chapter 3400, Telehealth Services

 Added to leave a spot to add a Quality Assurance Section
