## **Cost Study**

- Burns and Associates, a division of Health Management Associates, conducted a cost study between September 2020 and June 2021 under an RFP from DHCFP.
- The goals of the study were to administer a provider survey, analyze the survey results, and develop the proposed rates under an independent rate model.
- Rates were developed for Urban and Rural Regions
  - Differences in the rates are mostly due to distances and travel times.
  - BLS data did not show significant variation between Urban and Rural wages.



## **Survey Participation**

- The survey period was mid-February through mid-March 2021.
- 16 of the 88 (18.2%) ID Waiver providers responded to the survey.
- These providers accounted for 47.1% of expenditures during State Fiscal Year 2020.

#### Survey Results – Wages – Staff Wages

#### Survey Results – Wages – Staff Benefits

- \$502.97 per month for health insurance.
  - US DHHS Medical Expenditure Panel Survey, Private Sector in Nevada
- \$50.00 per month for other benefits
- Benefits were calculated as a percentage of the wage.
- An Hourly Staff Cost before Productivity was calculated by multiplying the based wage from the previous slide by 1 plus the benefits percentage.
  - For example, if the benefits percentage was 25% and the standard wage was \$10 an hour. The Hourly Staff cost before Productivity would be \$12.50.
- Paid time off was accounted for in the Productivity Adjustments section of the rate calculation.



#### Survey Results – Productivity Adjustments

- 25 Paid Days Off, equivalent to 3.85 hours per week.
- Training
  - 50 annual hours for training, except for training for master's and bachelor's level behavioral consultation providers.
  - 40 annual hours of training for master's and bachelor's level behavioral consultation providers.
- 45 minutes weekly for supervision, staff meeting, or other employer time.
- Travel time was calculated using participant and provider addresses.
  - Rural travel assumptions were set at 2.5 times the urban assumptions.
- Other Productivity Adjustments such as Missed Appointments were also included in the Model.



### Survey Results – Mileage

- Mileage is based on an analysis of participant and provider addresses.
- Rural Mileage is two and a half times the Urban milage.
- The rate per mile is \$0.56 per mile.



## Survey Results – Administration and Program Support

- Administrative rates were set at 10% for all services except Supplemental Residential Support.
- Administrative rates were set at 5% for Supplemental Residential Support.
- Program Support costs are funded at \$20 per day except for Day Habilitation Community services.
- Program Support costs are funded at \$25 per day for Day Habilitation Community services.

- The Residential Support Services Rates were calculated using 365 days and then were rescaled to 344 days.
  - For example, if the daily rate was calculated to be \$86. An annual total cost of 365 x \$86 = \$31,390 would be calculated. The \$31,390 would then be divided by 344, to get a final rate of \$91.25.

  - For example, if the daily rate was calculated to be \$86. An annual total cost of 365 x \$86 = \$31,390 would be calculated. The \$31,390 would then be divided by 344, to get a final rate of \$91.25.
