  - a. DHCFP is in the process of renewing the Home and Community Based (HCBS) Waiver for Person with Physical Disabilities (PD) application. This PD renewal must be submitted to the Centers for Medicare and Medicaid (CMS) Services for approval. Some of the enhancements and proposed changes are as follows:
    - 1. Addition of Private Case Management (PCM) Services as an option for recipients.
    - 2. Addition of Legally Responsible Adult (LRI).
    - 3. Restoration of 6% rate reduction.
    - 4. Enhancement of the Environmental Accessibility Adaptation (EAA) service from the American Rescue Plan Act (ARPA).
    - 5. Additional proposed changes.
  - b. DHCFP is in the process of amending the HCBS Waiver for Frail Elderly. The FE renewal must be submitted to CMS for approval. Some of the enhancements and proposed changes are as follows:
    - 1. Addition of PCM services as an option for recipients.
    - 2. Addition of LRI.
    - 3. Restoration of 6% rate reduction.
    - 4. Addition of Home Delivered Meals (HDM) service from ARPA.
